BAC Resolution Recommending the Contract via Negotiated Procurement through Request for Quotation (RFQ) and Approval of Committee's Finding

WHEREAS, ILOILO STATE UNIVERSITY OF FISHERIES SCIENCE AND TECHNOLOGY-Dingle Campus advertised the Negotiated Procurement through Request for Quotation (RFQ) No. 25-019 to Apply for Eligibility and to quote for the project "Supply, Delivery and Installation of Semi-Expendable Furniture and Fixtures" with the Approved Budget for the Contract (ABC) in the amount of Four Hundred Eighty-Nine Thousand Five Hundred Pesos Only (Php 489,500.00) the same at Philippine Government Electronic Procurement System (PHILGEPS) and conspicuous places at the premises of ISUFST Dingle Campus;
