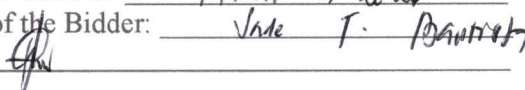

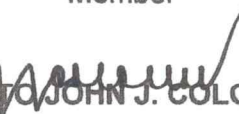

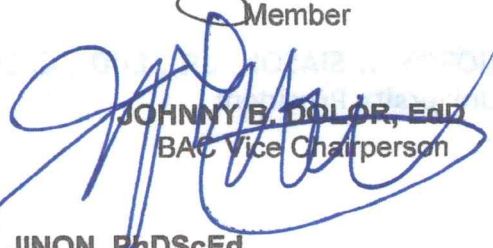

- d. BIR Tax Clearance (for ABC 50K and above)
- e. Income/Business Tax Return (for ABC 500K and above)
- f. Notarized Omnibus Sworn Statement (OSS)
- g. Special Power of Attorney (SPA) if applicable
- h. PCAB License (for Infra Projects)
