WHEREAS, the **ILOILO STATE UNIVERSITY OF FISHERIES SCIENCE AND TECHNOLOGY MAIN CAMPUS - POBLACION SITE** advertised the Invitation to Apply for Eligibility and to Bid for the project: **"REPAIR AND MAINTENANCE OF UNIVERSITY FACILITY (EXTERIOR CEILING OF CM AND CICT BUILDING AND SLAB SOFFIT OF CICT BUILDING)"** with the **Approved Budget of the Contract** in the amount **Three Hundred Fifty Nine Thousand Eight Hundred Pesos (Php 359,800.00)** the same in the Philippine Government Electronic Procurement System (PHILGEPS) continuously for 3 days;

WHEREAS, in response to the said advertisement, one (1) prospective bidder submitted its bid documents within the set deadline as per RFQ.

WHEREAS, the BAC adheres to the pass/fail criterion in the preliminary evaluation of the bids in accordance with the IRR of RA 12009;

WHEREAS, the result of the bid proposals found to be substantially complying as follows:



Contract Agreement Form for the Procurement of Infrastructure Projects (Revised)



CONTRACT AGREEMENT

THIS AGREEMENT, made this 7th day of July, 2025 between **ILOILO STATE UNIVERSITY OF FISHERIES SCIENCE AND TECHNOLOGY** represented by **NORDY D. SIASON JR., Ed.D., CESO VI**, University President, with office address at J.T. Bretaña St., Ilaya Poblacion, Barotac Nuevo, Iloilo and **MJ BARCELONA CONSTRUCTION AND SUPPLY**, with the office address at 259 Casa Barcelona, Brgy. Sambag, Jaro, Iloilo City by **MARY JEAN F. BARCELONA**, Owner/Authorized Representative, who has been authorized for this purpose as the **PARTY OF THE SECOND PART** hereinafter called the **CONTRACTOR**.

WHEREAS, the **ILOILO STATE UNIVERSITY OF FISHERIES SCIENCE AND TECHNOLOGY** is desirous that the **MJ BARCELONA CONSTRUCTION AND SUPPLY** execute **REPAIR AND MAINTENANCE OF UNIVERSITY FACILITY (EXTERIOR CEILING OF CM AND CICT BUILDING AND SLAB SOFFIT OF CICT BUILDING)** (hereinafter called "the Works") and the Entity has accepted the Bid for **THREE HUNDRED THIRTEEN THOUSAND EIGHT HUNDRED TWENTY PESOS (PHP313,820.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

 - c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and

- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **THREE HUNDRED THIRTEEN THOUSAND EIGHT HUNDRED TWENTY PESOS (PHP 313,820.00)** or such other sums as may be ascertained, **REPAIR AND MAINTENANCE OF UNIVERSITY FACILITY (EXTERIOR CEILING OF CM AND CICT BUILDING AND SLAB SOFFIT OF CICT BUILDING)** agrees to provide **Repair and Maintenance of University Facility (Exterior Ceiling of CM and CICT Building and Slab Soffit of CICT Building)** in accordance with his/her/its Bid.
4. The **ILOILO STATE UNIVERSITY OF FISHERIES SCIENCE AND TECHNOLOGY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




