KNOW ALL MEN BY THESE PRESENTS:

This contract made and entered into this 11th day of October year 2023 at Main Poblacion Campus, J.T. Bretaña St., Ilaya Poblacion, Barotac Nuevo, Iloilo.

The **ILOILO STATE UNIVERSITY OF FISHERIES SCIENCE AND TECHNOLOGY** represented by **NORDY D. SIASON, JR., Ed.D., CESO VI**, SUC President II, ISUFST, with office address at J.T. Bretaña St., Ilaya Poblacion, Barotac Nuevo, Iloilo as the **PARTY OF THE FIRST PART**, hereinafter called the **EMPLOYER** duly authorized for this purpose.

and
DOMBER SECURITY AGENCY INC. with the office address at Block 5 Lot 6, Bolilao, Mandurriao, Iloilo City by **ATTY. DOMINGO B. OSO, JR.** Owner, who has been authorized for this purpose as the **PARTY OF THE SECOND PART** hereinafter called the **CONTRACTOR**.

WITNESSETH:

Whereas the **CLIENT** wishes to engage the services of One (1) Security Guard to be assigned at Iloilo State College of Fisheries Barotac Nuevo Campus, Poblacion, Barotac Nuevo, Iloilo, Philippines, to protect its property and business interest against theft, pilferage, robbery, and unlawful acts and covenants as follows:

1. The Agency shall provide the Client with uniformed, armed, qualified and licensed security guard in such number as may be required to perform guard duties, at specified hours as the Client requires; and that said security guard posses the qualification required by pertinent laws;
2. The Agency shall be responsible for the damage of loss to the Client's property under its protection up to extent agreed upon, provided the damage and loss is directly attributed to the faults, negligence or failure of the security guard/s in the performance of their duties. The Agency is not liable for damage or loss due to fortuitous events, insuperable cause, force majeure (Acts of God), circumstances beyond the control of man or directly attribute to the fault or negligence of the Client, its employee agent or representative immediate member of the family and household;
3. That the Client in consideration of the services performed by the Agency shall pay the following:

77 days
8hrs/day, 30 days/month
1 Male (25-45 years old)
Uniformed, Armed and Licensed Security Guard
Contract of Duty: October 16, 2023 - December 31, 2023





The number of security Guard employed shall be increased or decreased as the case maybe at the discretion of the Client upon the recommendation of the Agency and upon acceptance of the CLIENT;

4. The agency shall have the right to replace by any security guard assigned to the Client with due notice to the Client for purposes of discipline and ion the operation of its internal affairs; and the same way, that the client upon request to the agency may cause, the replacement of any security guard assigned to the Client for any reason;
5. That the security guard assigned to the Client is not considered employees of the Client and liability whatsoever arising out of employer-employee relationship who shall be free from any and all liabilities during the tenure of this contract cannot be ascribed to the Client;
6. The Client shall have the right to inspect at anytime the performance of duties of security and may suggest to the agency to improve and/or enhance performance of duties;
7. In the case of failure to pay the services agreed, the Agency shall have the right to terminate this contract without prejudice to its claim for payment of services;
8. The agency undertakes to comply all provisions of the Labor Code and other applicable laws with respect to the guard assigned at the Client is not liable for whatever claims the guard may have against the Agency;
9. That all actions arising from this contract shall have its venue at the Municipal Trial Court of Iloilo or the Regional Trial Court;
10. That this contract shall commence on October 16, 2023 to December 31, 2023 subject to renewal upon mutual accord. In case either party wishes to terminate this contract before its expiration notice should be sent thirty (30) days prior to the said termination.


