



Contract Agreement Form for the Procurement of Goods (Revised)
[Not required to be submitted with the Bid, but it shall be submitted within ten (10) days after receiving the Notice of Award]

CONTRACT AGREEMENT

THIS AGREEMENT made on 25TH day of **August 2023** between **ILOILO STATE UNIVERSITY OF FISHERIES SCIENCE AND TECHNOLOGY** of the Philippines (hereinafter called "the Entity") of the one part and **ZURI HOTEL & SUITES** of **Bolilao Iloilo City** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly in the **FOOD AND VENUE FOR TRAINING WORKSHOP ON THE ESTABLISHMENT OF MAED AND PhD ED PROGRAMS-PHASE 4(FINALIZATION AND CRITIQUING) ON SEPTEMBER 1, 2023** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Seventy Six Thousand Five Hundred Pesos (P76,500.00)** (hereinafter called "the Contract Price").

 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Seventy Six Thousand Five Hundred Pesos (P76,500.00)** or such other sums as may be ascertained, **ZURI HOTEL & SUITES** agrees to provide **FOOD AND VENUE FOR TRAINING WORKSHOP ON THE ESTABLISHMENT OF MAED AND PhD ED PROGRAMS-PHASE 4(FINALIZATION AND CRITIQUING) ON SEPTEMBER 1, 2023** in accordance with his/her/its Bid.
