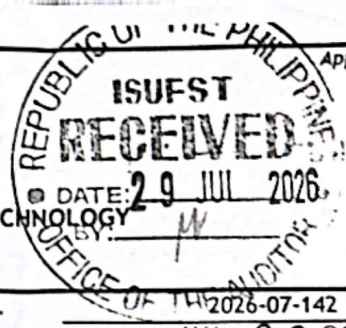

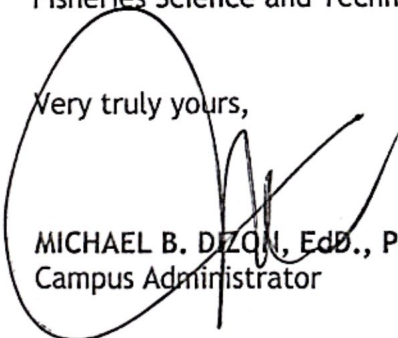

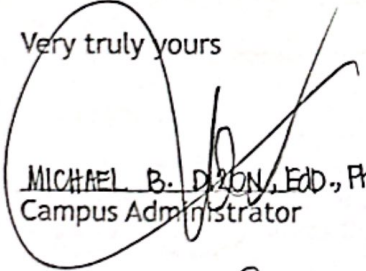

WHEREAS, the Iloilo State University of Fisheries Science and Technology, through its Bids and Awards Committee (BAC), conducted **Small Value Procurement** for **"Procurement of Semi-Expendable Office Equipment for the Second Quarter of FY 2026 ."**, with an Approved Budget for the Contract (ABC) of **Two Hundred Forty One Thousand Pesos (P241,000.00)**, in accordance with Republic Act No. 12009 (New Government Procurement Act) and its Implementing Rules and Regulations (IRR);

WHEREAS, the **Request for Quotation** was duly posted in the Philippine Government Electronic Procurement System (PhilGEPS) and in three (3) conspicuous places within the premises of the University for Ten (10) calendar days starting **June 19, 2026**, in compliance with RA 12009 and its IRR;

WHEREAS, the **Opening of RFQ (Canvass)** and **Bid Evaluation** were conducted on **June 29, 2026**, at **10:00 AM**, at the **University Conference Room Main Tiwi Site**, with the presence of the BAC, TWG, BAC Secretariat, and the End User;

WHEREAS, **three (3)** prospective bidders were sent RFQs (Canvass) via email and submitted their technical and financial requirements within the prescribed period, to wit:
