6. For the procurement of goods, the following quotation limited shall apply:

Semi-Expendable Items- Bidders shall quote a unit price NOT exceeding Fifty Thousand Pesos (Php50,000.00) per item.

Equipment Items- Bidders shall quote a unit price NOT lower than Fifty Thousand Pesos (Php50,000.00) per item.

Failure to comply with these quotation limits shall be grounds for disqualification of the bid.

Further, the BAC WILL NOT consider discounts upon the offered Bid in the Bid Form/RFQ, except if the distribution of the amount discounted is reflected on the Bidder's Tender/RFQ and Detailed Estimates.

The representative must present the original Special Power of Attorney (SPA)/Secretary Certificate.

The ISUFST Main Tiwi Site reserves the right to accept or reject any bid and to annul the bidding process any time before the contract award without incurring any liability to the affected Bidders and Bidder.
