

Whereas, the Hoilo State University of Fisheries Science and Technology Main Campus Poblacion Site advertised the Invitation to Apply for Eligibility to Bid for the Purchase and Delivery of Office Appliances with the ABC of Php 1,102,960.00 and posted it in Philgeps with Solicitation No. ITB2023-11-13 and Ref. No.10329113 and ISUFST Main Campus Poblacion Site Bulletin for 3 days;

Whereas, in response to the said advertisement, three (3) bidders submitted the application for eligibility to bid and was found eligible and passed the preliminary examination of bids on December 6, 2023 @ 9:00 a.m.;

The BAC extensively examined the documents and discovered that the lowest bidder, NIG Marketing, offers the brand Skyworth, however it is not the preferred brand as agreed by the bidders and end users.

With regards to this matter, the BAC members, together with the TWG members, have reached a consensus to develop a letter of disqualification to notify NIG Marketing Corporation that they have not met the agreed brand on November 7, 2023.


Furthermore, an onsite post-qualification will be conducted on the same day at NIG Marketing Corporation to conclude the findings that were observed during the Bid Evaluation process.


Whereas, on December 12, 2023 @ 9:00 a.m, in behalf of TWG Liezl B. Dula-ogon, TWG Emmanuel Tormon informed the BAC Chairman that through a thorough evaluation and onsite inspection, NIG Marketing Corporation was determined unresponsive and have not met the necessary brand as agreed upon the bidders and end-users.

Furthermore, NIG Marketing Corporation rendered an acceptance letter of their Disqualification Notice. By this, the TWG and BAC declared that NIG Marketing Corporation is the Lowest Calculated Bidder but is not qualified of fulfilling the agreed brand in the project.

Thus, the body decided to proceed to the Second Lowest Calculated Bidder which is ARMIX Copier Rentals Services and Sales. And its onsite inspection was scheduled on December 13, 2023.

Whereas, on December 14, 2023 @ 12:00 p.m upon careful examination, validation and verification of all the technical and financial requirements submitted by the bidder with the Lowest Calculated Bid Armix Copier Rentals Services and Sales has been found responsive;
